### **Important Details**

**WATER & ELECTRICITY:** NOT PROVIDED!! ONLY QUIET-CLEAN RUNNING GENERATORS ARE PERMITTED.

**BUSINESS LICENSE:** Vendors must comply with license requirements established by the City of Bracey, Virginia. Vendors are responsible for violations of such requirements.

### **BOOTH DETAILS**

#### Merchandise Vendors

- Vendor fee is \$25 per 10x10 space. Additional space will require an additional \$25 fee.

- Fees (products) are due by March 15, 2025 and should be mailed to **693 Martin Lane, Boyton, Virginia 23917** or **paid through eventbrite. The earlier the better.**
- Vendor space will be assigned by CCOV staff. We do not guarantee space requests.
- Vendors must provide their own booths and all equipment related to their booth.

### **Food Vendors**

- All food vendors are **required to pay a \$75 fee** to CCOV
- Fees must be paid by March 15, 2025. The earlier the better.
- All accepted food vendors **MUST Meet ALL Virginia Department of Health requirements**
- Anyone serving food is required to have a valid food facility/mobile unit permit
- Anyone not having a valid Virginia mobile unit permit for their truck/trailer will need to apply for and obtain a temporary event food permit
- All food vendors must submit copies of their current permits or submit an application and fee for a temporary event food permit to the Mecklenburg County Health Department, located at **969 Madison Street, Boydton, Virginia 23917, at least 35 days prior to the event. They can be reached at (434) 738-6815; Fax # (434) 738-6295**
- Inspections will be conducted by the Mecklenburg County Health Department the day of the event prior to permits being issued to the **temporary vendors**.
- A link to the Temporary Food Vendor permits FILLABLE application.pdf is provided on the CCOV website and Facebook page
- All food vendors setting up a booth must provide ground cover inside their booth and cooking area for the absorption of grease.
- No grease or grey water is to be poured on the ground. Anyone found doing this will be asked to leave the event.
- Food vendors will be responsible for all environmental cleanup cost related to their truck/booth.

### **Deposits/Returned Checks/Termination of Participation**

Fees are considered a deposit and guarantee of your participation. Fees will not be refunded/returned if you back out after April 1, 2025.

There will be a \$25 charge for any check returned as insufficient funds

**Vendors are expected to conduct themselves in a professional/appropriate/legal manner. CCOV reserves the right to remove any vendor for inappropriate/illegal acts**
